## **CONSENT ORDER**

AND UPON the Second CMC Order ordering at paragraph 26 that by 4pm on 7 June 2024 the Parties' experts for each of the foreign applicable laws shall meet (without the Parties) and discuss on a without prejudice basis according to the provisions of Civil Procedure Rule 35.12, and identify in joint memorandums (produced for each of the foreign applicable laws) filed with the Tribunal by no later than 4pm on 21 June 2024, clearly and concisely and in terms that can be understood by a non-expert, attaching any relevant documents, and with the assistance of the Parties' legal representatives where necessary: (a) the matters agreed between them; and (b) the areas in dispute between them

## IT IS ORDERED BY CONSENT THAT:

- 1. The date for filing and service of the Parties' expert reports in reply in the field of foreign applicable laws ordered at paragraph 25 of the Second CMC Order shall be varied to 4pm on 14 June 2024.
- 2. The date for the without prejudice meeting between the Parties' experts for each of the foreign applicable laws ordered at paragraph 26 of the Second CMC Order shall be varied to 4pm on 28 June 2024.
- 3. The date for the filing of joint memorandums for each of the foreign applicable laws ordered at paragraph 26 of the Second CMC Order shall be varied to 4pm on 12 July 2024.
- 4. No order as to costs.
