CONSENT ORDER

UPON the agreement set out in the letter from Travers Smith LLP to the claimants in the Second Wave Trucks Proceedings, dated 7 December 2023, regarding the disclosure of documents within the Commission’s administrative file

AND UPON the following definitions applying for the purpose of this Order:

- **“DAF Addressee Defendants”** means PACCAR Inc., DAF Trucks N.V. and DAF Trucks Deutschland GmbH
- **“VT/RT Addressee Defendants”** means AB Volvo (publ), Volvo Lastvagnar AB, Renault Trucks SAS and Volvo Group Trucks Central Europe GmbH

BY CONSENT IT IS ORDERED THAT:

1. Within one working day of this Order being made, the DAF Addressee Defendants shall provide to Edwards Transport (Shropshire) Limited (a Claimant in these proceedings) (**“Edwards Transport”**) the following disclosure, to the extent that such disclosure has not already been provided:
 - (a) the version of the decision of the European Commission dated 19 July 2016 in *Case AT.39824 – Trucks* disclosed pursuant to paragraph 11 of the Directions Order of Mrs Justice Rose dated 18 December 2017 in *Royal Mail Group Limited v DAF Trucks Limited & Others* (Claim No. HC-2016-003422; CAT Case No 1284/5/7/18 (T)) by the defendants in that claim;
 - (b) the versions of the documents on the European Commission’s administrative file relating to its investigation in *Case AT.39824 – Trucks* which were disclosed by the defendants in Case 1295/5/7/18 (T) *Dawsongroup plc and Others v DAF Trucks N.V. and Others*;
 - (c) the version of the index to the European Commission’s administrative file relating to its investigation in *Case AT.39824 – Trucks*, pursuant to paragraph 12 of the Order of Mr Justice Roth dated 19 December 2018 in *Case 1291/5/7/18 (T) Ryder Limited & another v MAN SE* and others by the DAF Addressee Defendants; and

- (d) the parent data of the documents on the European Commission's administrative file relating to its investigation in *Case AT.39824 – Trucks* which were disclosed in Case 1295/5/7/18 (T) *Dawsongroup plc and Others v DAF Trucks N.V. and Others*.
2. Within one working day of this Order being made, the VT/RT Addressee Defendants shall provide to Edwards Transport the following disclosure, to the extent that such disclosure has not already been provided: the relevant documents which are part of the European Commission's administrative file relating to its investigation in *Case AT.39824 – Trucks* which were previously withheld from disclosure and were disclosed pursuant to paragraph 1 of the Reasoned Order of Mr Andrew Lenon KC dated 11 November 2022 in Case 1295/5/7/18 (T) *Dawsongroup plc and Others v DAF Trucks N.V. and Others*.
3. Liberty to apply.
4. Costs in the case.
