CONSENT ORDER

UPON the request by Edwards Transport (Shropshire) Limited (a Claimant in these proceedings) (“Edwards Transport”) for certain “off-the-shelf” data, documents and information;

AND UPON the agreement set out in the letter from Freshfields Bruckhaus Deringer LLP to the claimants in the Second Wave Trucks Proceedings, dated 29 November 2023, regarding the provision of “off-the-shelf” disclosure;

AND UPON the confidentiality ring order of the President made on 17 June 2024 in these proceedings (the “Confidentiality Ring Order”);

BY CONSENT IT IS ORDERED THAT:

1. Within seven days of this Order being made, the Volvo/Renault Defendants shall provide to Edwards Transport the following:

 - (b) disclosure statements and guidance notes accompanying the disclosure outlined in the list above; and
 - (c) clarificatory correspondence relating to this disclosure that was exchanged in the VSW Proceedings between Freshfields Bruckhaus Deringer LLP and Hausfeld LLP, identified by the Volvo/Renault Defendants on a best endeavours basis.
2. The materials provided pursuant to this Order are designated Inner Confidentiality Ring Information pursuant to the Confidentiality Ring Order.
