ORDER

UPON the Tribunal having given judgment ([2024] CAT 39) on 7 June 2024 on the Class Representatives' revised applications for Collective Proceedings Orders

AND UPON the Tribunal making the Collective Proceedings Orders on 9 August 2024

AND UPON the Order of the Chair made on 22 August 2022

AND HAVING REGARD TO the letter from the solicitors for the Visa Defendants dated 17 September 2024, applying *inter alia* for an extension of the deadline for the filing of the Defence of the Visa Defendants.

AND HAVING REGARD TO the letter from the solicitors for the Mastercard Defendants dated 18 September 2024, *inter alia* supporting the Visa Defendants' application for an extension of the deadline for the filing of the Defences

AND HAVING REGARD TO the letter from the solicitors for the Class Representatives dated 18 September 2024 concerning *inter alia* the case management directions agreed between the parties

IT IS ORDERED THAT:

1. The Order of the Chair dated 22 August 2024 be varied as follows:
 - (a) The CMC on 8 October 2024 is vacated.
 - (b) A further CMC will be listed on the first available date 21 days after the Trial 1 judgment is handed down.
 - (c) The Defendants shall not be required to serve their Defences on 4 October 2024 and the time for so doing and for the service of Replies shall be generally extended until further order, with the expectation that further directions will be made at the CMC referred to in (b) above.
2. There be liberty to apply.
