CONSENT ORDER

UPON the Tribunal's composite Confidentiality Ring Order in the Coll Proceedings and Epic Proceedings made and drawn on 15 May 2024 (the **Composite CRO**)

AND UPON the Order of the Tribunal in the Coll Proceedings and Epic Proceedings made on 7 October 2024 and drawn on 23 October 2024 (the **Directions Order**)

AND UPON filing and service of the Class Representative's expert reports in the Coll Proceedings dated 2 October 2024 (the **CR Expert Reports**)

AND HAVING REGARD TO the Tribunal's powers under the Competition Appeal Tribunal Rules 2015

BY CONSENT IT IS ORDERED THAT:

1. The deadline in paragraph 3.3 of Schedule 2 to the Composite CRO as it applies to the CR Expert Reports shall be extended to **4pm on 8 November 2024**.
2. The deadline in paragraph 3.3 of Schedule 2 to the Composite CRO as it applies to documents referenced in the CR Expert Reports shall be extended to **4pm on 27 November 2024**.
3. The deadline in paragraph 18(a) of the Directions Order as it applies to the CR Expert

Reports shall be:

- 3.1. **6.30pm on 30 October 2024** in respect of those CR Expert Reports available on that date with the Defendants' confidential information highlighted and designated as per the designations in Schedule 1 to the Composite CRO, and
- 3.2. extended to **4pm on 8 November 2024** in respect of all other CR Expert Reports.
4. The Defendants shall disclose to the Class Representative copies of such CR Expert Reports referred to in paragraph 3.2 above with a blanket confidentiality designation as per Schedule 1 to the Composite CRO by **6.30pm on 30 October 2024**. The Class Representative shall disclose to Epic such blanket-designated CR Expert Reports within 2 days of the Defendants providing the Class Representative with such copies.
5. The Directions Order shall be amended such that the deadline in paragraph 7 of the Directions Order shall be extended to **4pm on 8 November 2024**.
